

Embrace a Tech: Veterinary Technician Student Scholarship

No purchase is necessary. A purchase does not increase an applicant's chances of winning.

This document outlines the Terms and Conditions for the Embrace a Tech: Veterinary Technician Student Scholarship (referred to as a "Scholarship" herein) administered by Embrace Pet Insurance (referred to as "Sponsor" herein). By submitting an application for this Scholarship, you are agreeing to these terms and conditions.

The Scholarship is subject to all applicable federal, state, and local laws, and regulations. This offer is void where prohibited.

You must read these Terms and Conditions in their entirety before you apply for and, if awarded accept a Scholarship offer. If selected, when you accept your Scholarship you are agreeing to and accepting these Terms and Conditions and agree to the requirements and conditions of your Scholarship.

Students in receipt of a Scholarship must meet all conditions as outlined in these Terms and Conditions.

1. **Eligibility:** The scholarship is open only to those who apply via the online application form and who are at least 18 as of the date of entry. Applicants must be a legal resident of the United States. Employees of the Sponsor and its affiliates, subsidiaries, advertising and promotion agencies, suppliers and their immediate family members and/or those living in the same household of each are not eligible.

Providing false or misleading information on your application is grounds for disqualification. 3. **Application Period:** Applications will be accepted online starting on 3/28/2019 and ending 6/15/2019. All online entries must be received by 6/15/2019 at 11:59PM EST.

4. **How to Apply:** Applications must be submitted using the [online application form](#). The application must fulfill all Scholarship requirements, as specified, to be eligible. Applications that are not complete or do not adhere to the rules or requirement, or these Terms and Conditions, may be disqualified at the sole discretion of the Sponsor. You may only apply once. You may not apply more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If you use fraudulent methods or otherwise attempt to circumvent the rules your submission may be removed from eligibility at the sole discretion of the Sponsor.

5. **Scholarships:** Three winners will be selected from the pool of eligible applicants. The total value of each Scholarship is \$1,000. The Scholarship is non-transferable.

Your acceptance of a Scholarship will constitute your permission for the Sponsor to use your name, likeness, and entry for purposes of advertising and trade without further compensation, unless prohibited by law.

6. **Odds:** The odds of winning depend on the number of eligible entries received.

7. Winner selection and notification: Essays, volunteer experience, and academic qualification will be reviewed by the Sponsor's scholarship selection panel. Essay submissions will be judged on creativity as well as use of proper grammar and spelling.

All applicants offered Scholarships will receive an official "offer" email by 7/15/2019 offering the Scholarship and requiring the applicant's confirmation to be bound by these Terms and Conditions, and must reply either accepting or rejecting this offer within 14 days of receipt.

Failure to respond within this 14-day period may result in the Scholarship offer being withdrawn and reassigned. An applicant offered must accept the Scholarship offer by the due date, as instructed in the offer email, to be eligible to receive payment.

Correspondence between applicants and the Sponsor will be conducted primarily via email, with the option of telephone communication in the Sponsor's sole discretion. Any changes to the applicant's email address submitted with the application, after submission of application and without necessary cause, may result in cancelation of application.

The Sponsor shall have no liability for a selected applicant's failure to receive notices due to such applicant's spam, junk e-mail or other security settings or for the applicant's provision of incorrect or otherwise non-functioning contact information. If a selected applicant cannot be contacted, is ineligible, fails to accept the Scholarship within 14 days from the time award notification was sent, or fails to timely return a completed and executed declaration and releases as required, the Scholarship may be forfeited and an alternate winner selected.

8. Scholarship Disbursement: The Sponsor will make payment of the funds in one single installment, though the Sponsor reserves the right to make payment in multiple installments, in the Sponsor's sole discretion.

The Scholarship funds will be paid via check made out to each winning applicant.

An applicant must meet the eligibility requirements on the [Scholarship page of the Sponsor's website](#) to be eligible to receive a Scholarship, if selected.

9. Rights Granted by you: By applying you understand that the Sponsor, anyone acting on behalf of the Sponsor, or their respective licensees, successors and assigns will have the right, where permitted by law, without any further notice, review or consent to print, publish, broadcast, distribute, and use, worldwide in any media now known or hereafter in perpetuity and throughout the World, your entry, including, without limitation, the entry and winner's name, portrait, picture, voice, likeness, image or statements about the Scholarship, and biographical information as news, publicity or information and for trade, advertising, public relations and promotional purposes without any further compensation.

Terms: The Sponsor reserves the right, in its sole discretion to cancel, terminate, modify or suspend the Scholarship should (in its sole discretion) a virus, bugs, non-authorized human intervention, fraud or other causes beyond its control corrupt or affect the administration, security, fairness or proper conduct of the Scholarship application process. In such case, the Sponsor may select the recipients from all eligible entries received prior to and/or after (if appropriate) the action taken by the Sponsor. The Sponsor reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Scholarship application or website or violates these Terms and Conditions.
